

Subway® Bread Research - Prize draw terms and conditions

These terms and conditions (these Terms) apply to prize draws specified below and undertaken by The Nursery Research and Planning Ltd. (The Nursery Research & Planning).

1. These Terms form the whole contract governing the operation and your entry into the prize draw to win 1 of 5 prizes of a £50 Amazon gift card. Each winner will receive 1 Amazon gift card of £50 (the Prize Draw).
2. By entering the Prize Draw you confirm that you agree to be bound by these Terms.
3. The opening date for this prize draw is 22nd December 2021 UK time.
4. The closing date for this prize draw is midnight on 10 February 2022 UK time (the Closing Date).
5. Entries are made by completing the Subway® bread experience survey.
6. The draw will take place on 11 February 2022 and the winners will be notified in accordance with these Terms on or before 18 February 2022.
7. This Prize Draw is conducted by The Nursery Research & Planning.
